**PUBLIC HEARING
June 16, 2016**

A public hearing on its proposed FY 2016-2017 Budget was held on June 16, 2016 by the Central Connecticut Health District Board of Health. The hearing was convened at 6:00 pm in the Lienhard Room of the Lucy Robbins Welles Public Library, Newington, CT.

Kristine Nasinnyk, Chairman of the Finance Committee of the Board of Health, served as the hearing officer.

The purpose of the hearing was to seek public comment and suggestions on the proposed annual budget for the health district for FY 2016-2017. Copies of the proposed budget were made available at the hearing.

A notice of hearing was posted on June 2, 2016 and sent to the Town Clerks in each of the member towns in the Health District – Berlin, Newington, Rocky Hill and Wethersfield - and also published on June 2, 2016, in the Hartford Courant in editions serving each member town. The notice of hearing and the proposed budget summary were also posted on the Health District website and were available from CCHD headquarters.

Nasinnyk entered the hearing notice, and the proposed budget into the hearing record.

No oral testimony was presented. No written testimony or letters were received related to this issue.

Seeing no others in attendance, the public hearing was recessed, but held open until 6:30 pm.

At 6:30 p.m. Nasinnyk thanked those who attended, and advised that copies of the proceedings of this hearing will be made available on the CCHD website by Tuesday, June 21, 2016 and may also be requested from CCHD headquarters.

Nasinnyk declared the public hearing closed at 6:30 pm.
