**PUBLIC HEARING
June 18, 2015**

A public hearing on its proposed FY 2015-2016 Budget was held on June 18, 2015 by the Central Connecticut Health District Board of Health. The hearing was convened at 6:00 pm in the Lienhard Room of the Lucy Robbins Welles Public Library, Newington, CT.

Kristine Nasinnyk, Chairman of the Finance Committee of the Board of Health, served as the hearing officer.

The purpose of the hearing was to seek public comment and suggestions on the proposed annual budget for the health district and agency fee schedule for FY 2015-2016. Copies of the proposed budget and fee schedule were made available at the hearing.

A notice of hearing was posted on June 9, 2015 and sent to the Town Clerks in each of the member towns in the Health District – Berlin, Newington, Rocky Hill and Wethersfield -- and also published on June 3, 2015 and June 7, 2015, in the Hartford Courant in editions serving each member town. The notice of hearing, proposed budget summary and proposed fee schedule were also posted on the Health District website and were available from CCHD headquarters.

Nasinnyk entered the hearing notice, the proposed budget and the proposed fee schedule into the hearing record.


No oral testimony was presented. No written testimony or letters were received related to this issue.
