Late Fee for all Annual Licenses (FSE, Salons, Pools, Motel):

Renewal received within 30 days of license expiration- \$50.00 late fee

Renewal received within 31 to 60 days of license expiration- \$100.00 late fee

After 60 days non-renewal, revoke licensure- Reinstatement Fee double license fee

Late Fee for Temp Food License: If application received late, 4-14 days before event= 50% License Fee; 1-3 days=100% License Fee
